## FUND DESCRIPTION

The Vetiva Banking ETF "VETBANK ETF" is an open-ended Exchange Traded Fund managed by Vetiva Fund Managers Limited. The VETBANK ETF is designed to track the performance of the constituent companies of the NGX BANKING Index and to replicate the price and yield performance of the Index.

## INDEX DESCRIPTION

The NGX BANKING Index comprises of the top 10 banks listed on the Nigerian Exchange Group ("NGX") in terms of market capitalization and liquidity and is a price index weighted by adjusted market capitalization.

## MARKET REVIEW & OUTLOOK

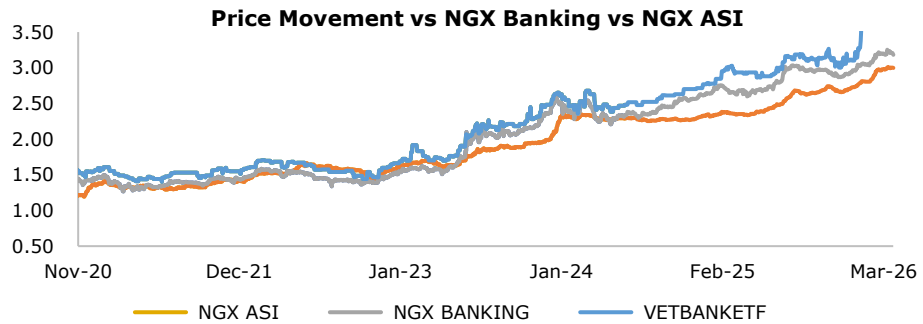
At the end of the first quarter of 2026, the Nigerian equities market sustained its upward momentum, albeit at a more moderate pace compared to preceding months, as the NGX All-Share Index (ASI) closed with a month-on-month gain of +4.39% to settle at 201,287.78 points. This brought the year-to-date (YTD) and quarter-to-date return to +29.35%

Within the banking space, the Index declined by 1.66% m/m, losing momentum compared to the prior month. The downturn was broad-based, with notable losses in FCMB (-15.11%), FIRSTHOLDCO (-7.32%), GTCO (-3.72%) and UBA (-4.92%) among others with STANBIC (+9.10%) and ZENITH (+5.27%) as the only counter-closing positive. However, the Banking sector advanced 22.75% q/q as it concluded its recapitalization phase, with investors positioning ahead of anticipated earnings releases.

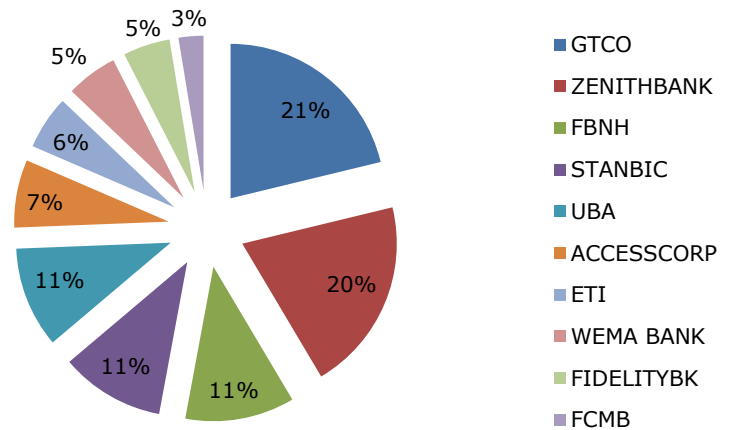
Looking ahead, we maintain a strong positive outlook, on the back of the just completed recapitalization (with ₦4.65 trillion raised), resilient FY'25 core earnings, >10% dividend yields from Tier 1 banks, with further upside from pending results. .
