FUND DESCRIPTION

The Vetiva Industrial ETF "VETIND ETF" is an open-ended Exchange Traded Fund managed by Vetiva Fund Managers Limited. The VETIND ETF is designed to track the performance of the constituent companies of the NGX Industrial Index and to replicate the price and yield performance of the Index.

INDEX DESCRIPTION

The NGX Industrial Index comprises of the top 10 companies in the Industrial sector listed on the Nigerian Exchange Group ("NGX") in terms of market capitalization and liquidity and is a price index weighted by adjusted market capitalization.

MARKET REVIEW & OUTLOOK

The Nigerian equities market maintained its upward trajectory in May 2026, recording a moderate but positive performance relative to the preceding month. The NGX All-Share Index (ASI) advanced by 3.35% m/m to close at 250,385.70 points, bringing its year-to-date gain to 60.90%

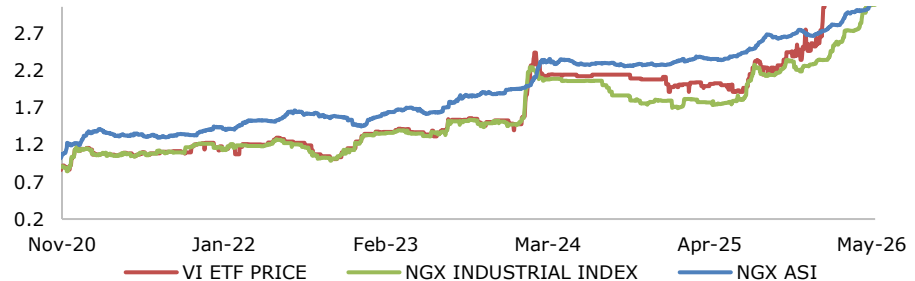
On a sectoral basis, the Industrial Goods Index maintained its positive streak, gaining 8.60% m/m. Despite mixed performance within the sector, we saw impressive gains in AIRTEL (+21.00%), DANGCEM (+21.65%), BERGER (+80.55%), and other notable counters. However, these gains were tempered by losses in some constituents, including WAPCO (-2.29%) and TRIPPLEG (-6.57%). On a year-to-date basis, the index has delivered a return of +115.74%, significantly outperforming the broader market.

Looking ahead we expect a neutral sentiment in June as most of Q1'26 earnings have already been released. The introduction of the T+1 settlement cycle from June 1 is anticipated to enhance market liquidity and trading activity by shortening settlement periods and facilitating faster capital redeployment.

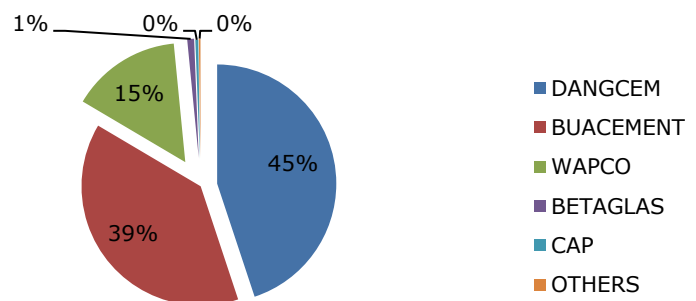
