FUND DESCRIPTION

The Vetiva Consumer ETF "VETGOODS ETF" is an open-ended Exchange Traded Fund managed by Vetiva Fund Managers Limited. The VETGOODS ETF is designed to track the performance of the constituent companies of the NGX Consumer Goods Index and to replicate the price and yield performance of the Index.

INDEX DESCRIPTION

The NGX Consumer Goods Index comprises of the top 15 companies in the Food/Beverages and Tobacco sector listed on the Nigerian Exchange Group ("NGX") in terms of market capitalization and liquidity and is a price index weighted by adjusted market capitalization.

MARKET REVIEW & OUTLOOK

The Nigerian equities market sustained its positive run in September, as the NGX All-Share Index (ASI) advanced by 1.72% m/m to close at 142,708.71 points, extending the year-to-date (YTD) return to 38.65%.

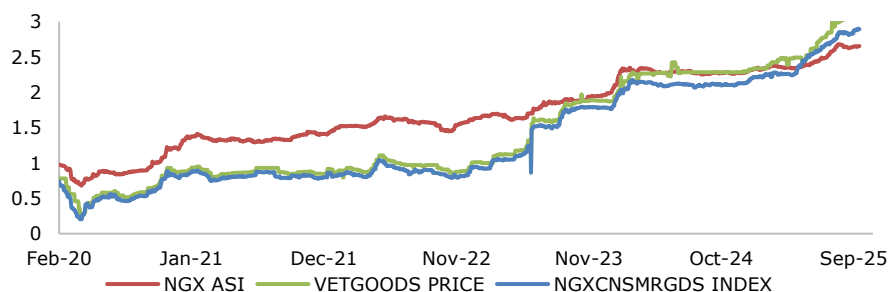
The Consumer Goods Index recorded another impressive run, closing the month with a 5.65% m/m growth. The performance was underpinned by sustained demand for large-cap tickers such as BUAFOODS (+6.73%), DANGSUGAR (+5.17%), and GUINNESS (+41.46%).

Going into October, sentiment within the Consumer Goods sector is expected to remain broadly positive, supported by stable product demand, resilient pricing, and sustained investor interest. However, short-term volatility may arise from potential profit-taking after the recent strong rally, as well as fluctuations in input prices and FX availability. Overall, the sector's outlook remains moderately bullish. The NGX Consumer Goods Index remains impressively up 94.66% year-to-date.

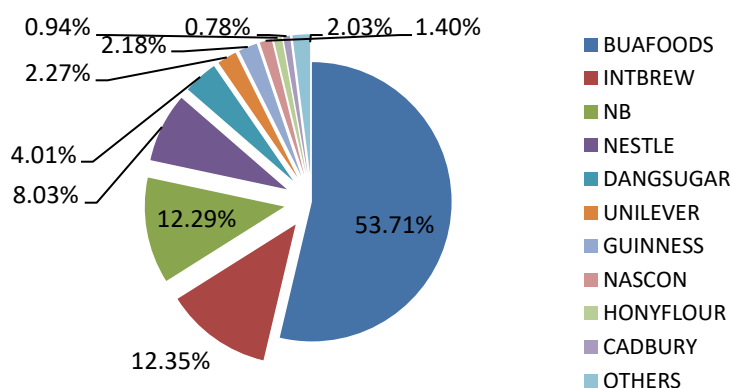
