FUND DESCRIPTION

The Vetiva Consumer ETF "VETGOODS ETF" is an open-ended Exchange Traded Fund managed by Vetiva Fund Managers Limited. The VETGOODS ETF is designed to track the performance of the constituent companies of the NGX Consumer Goods Index and to replicate the price and yield performance of the Index.

INDEX DESCRIPTION

The NGX Consumer Goods Index comprises of the top 15 companies in the Food/Beverages and Tobacco sector listed on the Nigerian Exchange Group ("NGX") in terms of market capitalization and liquidity and is a price index weighted by adjusted market capitalization.

MARKET REVIEW & OUTLOOK

The All-Share Index (ASI) continued firmly in positive territory in February, gaining 3.18% monthon-month (m/m) with the ASI closing the month at 107,821,39 points resulting in a YTD gain of 4.76%. Similarly, the NGXCNSMRGDS Index mirrored this positive close, gaining 1.70% m/m.

Narrowing down to the Consumer Goods Sector, the index gained 1.07% m/m. While NESTLE exhibited a flat performance and NB experienced a decline of 2.79%, we observed a bullish run in NASCON (+18.95% m/m), DANGSUGAR (+11.11% m/m) and HONEYFLOUR (+43.01% m/m). Additionally, large-cap BUAFOODS posted a modest gain of 0.72%m/m, contributing to the sector's overall performance.


Looking ahead, we anticipate a mixed performance for Consumer Goods, noting that the sector has recorded a 6.25% gain year-to-date, we see room for some profit taking even as corporate releases are expected to roll in.
