FUND DESCRIPTION

The Vetiva Griffin 30 ETF "VG 30 ETF" is an open-ended Exchange Traded Fund managed by Vetiva Fund Managers Limited. The VG 30 ETF is designed to track the performance of the constituent companies of the NGX 30 Index and to replicate the price and yield performance of the Index.

INDEX DESCRIPTION

The NGX 30 Index comprises of the top 30 companies listed on the Nigerian Exchange Group ("NGX") in terms of market capitalization and liquidity and is a price index weighted by adjusted market capitalization.

MARKET SUMMARY

In December, the equity market closed the year in green with a gain of 4.78% month-on-month (m/m) extending its bullish run. The market activity was dominated by local investors in anticipation of FY'23 financials and final dividend declaration. Mirroring the ASI performance, the NGX 30 Index closed in the green with a 6.28% month-on-month (m/m) gain following the northward movement of some highly capitalized stocks.

On a sectoral basis, the Consumer Goods Index declined by 1.81%m/m following the decline in some highly capitalized stocks like BUAFOODS (-2.77%) m/m, DANSUGAR (-1.72%) m/m and NESTLE (-4.25%) m/m among others. The Banking Index was the best performing Index, closing northward with gains of 19.94% m/m. The Industrial Goods sector declined by -2.52% month-on-month (m/m) the eastward movement was attributed to the decline in BUACEM (-6.73%) m/m. The Oil and Gas Sector closed in the red losing 0.34% (m/m).


In Q1 2024, we expect FY corporate releases to influence trading sentiment as domestic investors continue to drive trading activity in the equity market.
