FUND DESCRIPTION

The Vetiva Industrial ETF "VETIND ETF" is an open-ended Exchange Traded Fund managed by Vetiva Fund Managers Limited. The VETIND ETF is designed to track the performance of the constituent companies of the NGX Industrial Index and to replicate the price and yield performance of the Index.

INDEX DESCRIPTION

The NGX Industrial Index comprises of the top 10 companies in the Industrial sector listed on the Nigerian Exchange Group ("NGX") in terms of market capitalization and liquidity and is a price index weighted by adjusted market capitalization.

MARKET REVIEW & OUTLOOK

Year to date, the All-Share Index remained well in positive territory, returning 30.40%. However, on a month-on-month basis, a 15-bps loss was recorded by the All-Share Index.

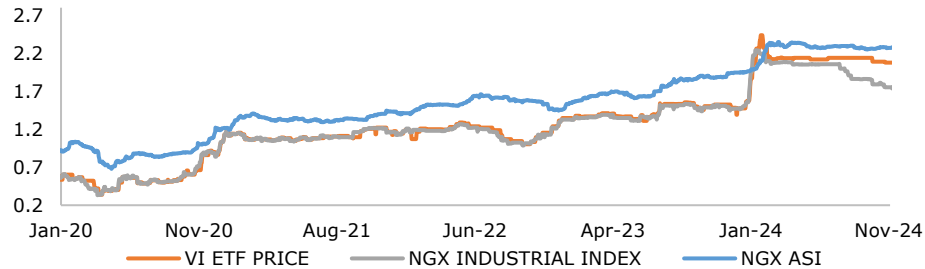
On a sectorial basis, the Industrial Goods Index returned 2.14% m/m. This gain was driven majorly by the significant 50.65% m/m appreciation in WAPCO which outweighed the loss recorded in BUACEMENT (-2.86% m/m) and the flat close in DANGCEM. We note that DANGCEM, BUACEMENT and WAPCO contribute about 96.74% to the Industrial Goods Index and the performances of these stocks steer the direction of the Industrial Goods Index. The upward sprout in WAPCO can be attributed to speculations regarding the sale of the company by Holcim Group, its parent company.

Looking ahead, we anticipate a positive outlook for the Industrial Goods Sector as we expect investors to continue to react positively to the announcement regarding the acquisition of WAPCO at an estimated acquisition price of c.N100. We expect these possible gains to outpace possible profit taking activities across other major counters in the index as investors begin wind down activities for the year.

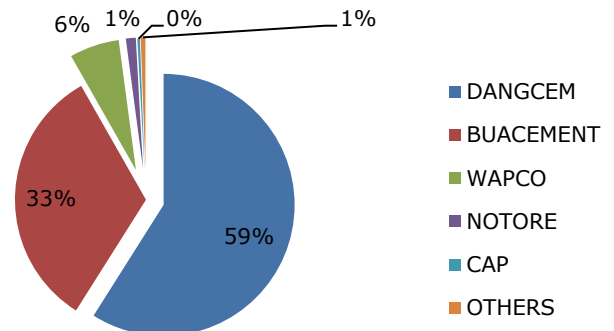
